4. Superintendent's Remarks

Dr. Caputo reported updates on where the District stands as virtual learning continues. Governor Murphy has closed schools for the rest of the school year, and our last day of school is June 19th. We are continuing lunch delivery service for any student in need, regardless of free and reduced lunch status. We have made 24 home visits, checking in with students and their families. Nurses are working to return medications that have been stored at the schools (a contactless exchange). Our Summer Institute registration is underway (most programs are

planning to be remote). The District is planning various virtual end of year events, including graduation. We are working on year-end plans (including cleaning out lockers, returning books etc), and we are also looking at reopening plans for the fall (and will have contingency plans if we are unable to open). Dr. Caputo also gave an update on grading (which was also reported at previous meeting): Moss – progress reports as normal; Campbell – focusing on narrative (paragraph format) rather than letters; Edgar is now Pass/Fail for MP4. MHS has canceled finals and adjusted the weighting of the marking periods (28% for each MP1-3; MP4 is 28%).

Mr. Manley thanked the teachers and administration for their continued hard work and support.
