6. RESOLUTION PROVIDING FOR THE SUBMISSION OF TWO BOND PROPOSALS AND A GENERAL FUND ADDITIONAL SPENDING PROPOSAL AT THE ANNUAL SCHOOL ELECTION ON NOVEMBER 8, 2022, FOR CONSIDERATION BY THE LEGALLY QUALIFIED VOTERS OF THE SCHOOL DISTRICT.

BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE BOROUGH OF METUCHEN IN THE COUNTY OF MIDDLESEX, NEW JERSEY (with not less than a majority of the full membership of the Board concurring) AS FOLLOWS:

1. It is hereby determined that two bond proposals and a general fund additional spending proposal will be submitted for voter approval at the Annual School Election to be held on November 8, 2022. The form of the proposals and questions, together with the interpretive statement, to be submitted to the voters will read substantially as follows with such changes as bond counsel may require:

RECONFIGURATION IMPROVEMENTS BOND PROPOSAL QUESTION No. 1

The Board of Education of the Borough of Metuchen in the County of Middlesex, New Jersey is authorized: (a) to provide for additions, renovations, alterations and improvements at Moss Elementary School, Campbell Elementary School, Edgar Middle School and Metuchen High School, including fixtures, furnishings, equipment, site work and related work; (b) to appropriate \$71,682,187 for such purposes, including \$2,200,000 from capital reserve, and (c) to issue bonds of the school district in the principal amount of \$69,482,187.

The final eligible costs of the projects approved by the Commissioner of Education are \$29,816,978 (with \$9,910,468 allocated to Moss Elementary School, \$6,200,344 allocated to Campbell Elementary School, \$4,259,924 allocated to Edgar Middle School and \$9,446,242 allocated to Metuchen High School. The cost of the projects includes \$377,520 allocated to Moss Elementary School, \$26,455 allocated to Campbell Elementary School, \$2,120,690 allocated to Edgar Middle School, and \$2,204,345 allocated to Metuchen High School for elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects. The Board of Education is authorized to transfer funds among the facilities projects approved at this election.

This Bond Proposal in Question No. 1 will take effect only if the Additional Spending Proposal Question No. 2 is also approved by the voters at this Annual Election.

ADDITIONAL SPENDING PROPOSAL QUESTION No. 2

PROPOSAL FOR ADDITIONAL FUNDS

RESOLVED that there shall be raised an additional \$800,000 for General Funds in the 2022-2023 School Year. These taxes will be used exclusively for additional costs required for the School District Grade Level Reconfiguration including Full Day Kindergarten, additional costs for salaries, benefits and/or other compensation or expense as required for teachers, specials, basic skills, special education, counselors, paraprofessionals and lunch room aids, curriculum, technology, facilities operating costs, utilities, transportation and related costs. Approval of these taxes will result in a permanent increase in the district's tax levy. These proposed additional expenditures are in addition to those necessary to achieve the New Jersey Student Learning Standards. This proposal will take effect only if the school bond proposal to finance the reconfiguration facilities improvements (Bond Proposal in Question No. 1) is also approved by the voters at this Annual Election.

HIGH SCHOOL GYM ADDITION BOND PROPOSAL QUESTION No. 3

The Board of Education of the Borough of Metuchen in the County of Middlesex, New Jersey is authorized: (a) to provide for an additional gym and related facilities at Metuchen High School, including field and athletic facilities improvements, fixtures, furnishings, equipment, site work and related work; (b) to appropriate \$12,754,038 for such purposes and (c) to issue bonds of the school district in the principal amount of \$12,754,038.

The final eligible costs of the project approved by the Commissioner of Education are \$1,008,403. The cost of the project includes \$2,851,706 for elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the project. The Board of Education is authorized to transfer funds among the facilities projects approved at this election.

This Bond Proposal in Question No. 3 will take effect only if it is approved by voters and the Bond Proposal in Question No. 1 and the Additional Spending Proposal in Question No. 2 are also approved by the voters at this Annual Election.

INTERPRETIVE STATEMENT

For the bond proposal in question no. 1 and the additional spending proposal in question no. 2 to go into effect, both the bond proposal in question no. 1 and the additional spending proposal in question no. 2 must be approved by the voters at this election and go into effect. For the bond proposal in question no. 3 to go into effect, the proposals in questions nos. 1, 2 and 3 all must be approved by voters at this election and go into effect. If all three proposals are approved by the voters at this election, the Board of Education will be authorized to undertake school capital projects for a total cost of \$84,436,225, to spend \$2,200,000 from capital reserve and to issue bonds in the total principal amount of \$82,236,225 to fund the projects. The aggregate amount of the final eligible costs of the facilities projects approved by the Commissioner of Education is \$30,825,381 (with \$9,910,468 allocated to Moss Elementary School, \$6,200,344 allocated to Campbell Elementary School, \$4,259,924 allocated to Edgar Middle School and \$10,454,645 allocated to Metuchen High School. The proposed improvements include \$377,520 allocated to Metuchen High School on \$26,455 allocated to Campbell Elementary School, \$2,120,690 allocated to Edgar Middle School and \$5,056,051 allocated to Metuchen High School construction elements in addition to the facilities efficiency standards developed by the Commissioner of Education or not otherwise eligible for State support pursuant to N.J.S.A. 18A:7G-5(g). The State debt service aid percentage will equal 40% of the annual debt service due with respect to the final eligible costs of the projects approved at this election. If all three proposals are approved, the district is authorized to spend an additional \$800,000 in the General Fund above the tax levy cap in fiscal year 2022-23, and the authorization will result in a permanent increase in the district's tax levy cap.

- 2. This Board of Education hereby approves and adopts the bond proposals set forth as Questions 1 and 3 above, and, subject to the approval of the legal voters of the school district, hereby determines to carry out the improvements described therein (the "Projects"). This Board of Education previously approved and adopted the Additional Spending Proposal set forth above and, subject to the approval of the legal voters of the school district as set forth therein, hereby determines to carry out the purposes described therein.
- 3. This Board of Education hereby acknowledges and confirms that in accordance with N.J.S.A. 18A:24-16 and 18A:24-17 a supplemental debt statement has been prepared by the chief financial officer of the Borough of Metuchen (the "Borough"), giving effect to the proposed authorization of bonds of the school district in the maximum amount of bonds authorized in the bond proposals. The supplemental debt statement has been filed in the office of the Borough Clerk and in the office of the Business Administrator/Board Secretary of this Board of Education prior to the adoption of the proposals and will be filed in the office of the Director of the Division of Local Government Services in the Department of Community Affairs prior to the date of the election.
- 4. The Business Administrator/Board Secretary is hereby authorized and directed to send a certified copy of the proposal questions, together with the interpretive statement, to the County Clerk as required by N.J.S.A. 19:60-2 and to request the County Clerk to submit the proposal questions, together with the interpretive statement, to the voters at the annual school district election scheduled for November 8, 2022.
- 5. The Board of Education hereby acknowledges receipt of the Preliminary Eligible Costs (PEC) letters for the Projects from the Department of Education. The Board hereby elects to receive debt service aid pursuant to Section 9 of the Educational Facilities Construction and Financing Act, N.J.S.A. 18A:7G-1 et seq. (the "Act"). The Board further agrees to accept the determination of the space eligible for State support and the preliminary eligible costs as final eligible costs as set forth in the PEC letters by the Department of Education and not to appeal. The Business Administrator/Board Secretary is authorized, if necessary, to notify the Department of Education of the Board's election with respect to the eligible spaces and costs and its election to receive debt service aid.
- 6. EI Associates Architects & Engineers, P.A., the School District's appointed architect for the Projects (the "Project Architect"), has heretofore been authorized and delegated the responsibility to prepare the plans and specifications for the Projects in consultation with and under the supervision of the Business Administrator/Board Secretary, who has heretofore been delegated the responsibility to work with the Project Architect for this purpose on behalf of the Board of Education, in accordance with the requirements of N.J.S.A. 18A:18A-16, and such authorizations and delegations are hereof reconfirmed.
- 7. The educational plans, where required, and the schematic plans for the construction of the Projects have heretofore been approved by this Board of Education, and such approval is hereby reconfirmed.
- 8. The Board President, the Superintendent of Schools, the Business Administrator/Board Secretary, the Project Architect, Bond Counsel and other appropriate representatives of the Board of Education (the "Board Representatives") have heretofore been authorized, and such authorization is hereby reconfirmed, to submit the educational plans, where required, and the schematic plans for the Projects, together

with such other information as may be required, to the State Department of Education for approval and to make application to the Commissioner of Education for approval of the educational plans, where required, the schematic plans and the Projects and, if necessary, any required amendment to the long-range facilities plan, in accordance with the requirements of the Act and N.J.A.C. 6A:26-2.1(f), 6A:26-2.3(c), 6A:26-3.1 and 6A:26-3.2, as appropriate.

- 9. The Board Representatives have heretofore been and are hereby further authorized and directed to submit the plans and any other required information to the Planning Board and the Department of Environmental Protection for review and comment as necessary, and such authorization and direction are hereby reconfirmed.
- This Board of Education hereby makes the following covenants and declarations obligations determined to be issued by the to Administrator/Board Secretary through a public offering or private placement or through a conduit borrower on a tax-exempt basis. The Board of Education hereby covenants that it will comply with any conditions subsequent imposed by the Internal Revenue Code of 1986, as amended (the "Code"), in order to preserve the exemption from taxation of interest on its bonds or notes if issued as tax exempt, including, if necessary, the requirement to rebate all net investment earnings on the gross proceeds above the yield on its bonds or notes. The Business Administrator/Board Secretary is hereby authorized to act on behalf of the Board of Education to deem any obligations authorized herein as Bank Qualified for the purposes of Section 265 of the Code, when appropriate. The Board of Education hereby declares the intent of the Board of Education to issue bonds or temporary notes in the amount not to exceed the amount set forth in the bond proposal approved by the voters as set forth in Section 1 and to use the proceeds to pay or to reimburse expenditures for the costs of the school capital projects authorized therein. This resolution is a declaration of intent within the meaning and for purposes of Treasury Regulations §1.150-2 or any successor provisions of federal income tax law.
- 11. The proceeds of bonds issued pursuant to the bond proposals set forth herein shall be used first for the capital projects authorized herein and any remaining capital reserve funds not used for the projects will be restored to the capital reserve account.
- 12. The Board Representatives are hereby authorized to take all steps necessary to implement this resolution. Any actions authorized herein and taken prior hereto are hereby ratified. The Business Administrator/Board Secretary is further authorized to act on behalf of the Board of Education to make such determinations required of the Board of Education for the conduct of the election as may become necessary.
- 13. The reference to officers of this school district herein includes the Vice President in the absence or unavailability of the President and any deputy, interim, acting or successor officer holding each position.
- 14. This resolution shall take effect immediately.
