Ms. Cecelia Rezes and Ms. Ehrin Ziccardi on behalf of 36 families request the 15 year old non-bussing area map for Edgar Middle School be re-evaluated and revised to accommodate students who travel hazardous roadways to Edgar Middle School every day. They would like courtesy bussing extended to children that have to walk along busy roadways. Current non-bussing areas don't support the growing community. Please review the request and provide answers to the questions.

Mr. Benderly reviewed the historical aspects of Metuchen bussing. By law the district is not required to provide bussing to Edgar Middle School. Courtesy bussing started when schools changed configurations. The non-bussing zones haven't changed in the past 15 years. The board will continue to discuss the issues.

Mr. Harvier and Mr. Manley explained that the non-bussing zones haven't changed in the past 15 years and the public school transportation bidding process and potential hazards.

Ms. McGuire also asked where the process to reassess the K-8 bussing begins, would the district hire a consultant or handle administratively. Ms. McGuire indicated that is issue should be discussed during the feasibility study options.
