10. Adoption of the 2016-2017 Tentative School Budget

WHEREAS, The Board of Education is requesting authority to utilize \$124,891 in unused spending for an unusual increase in special education costs and these cost must be utilized by the end of the budget year and cannot be deferred or incrementally completed over a longer period of time.

NOW THEREFORE BE IT RESOLVED that the Metuchen Board of Education adopt the tentative 2016-2017 school district budget as follows:
