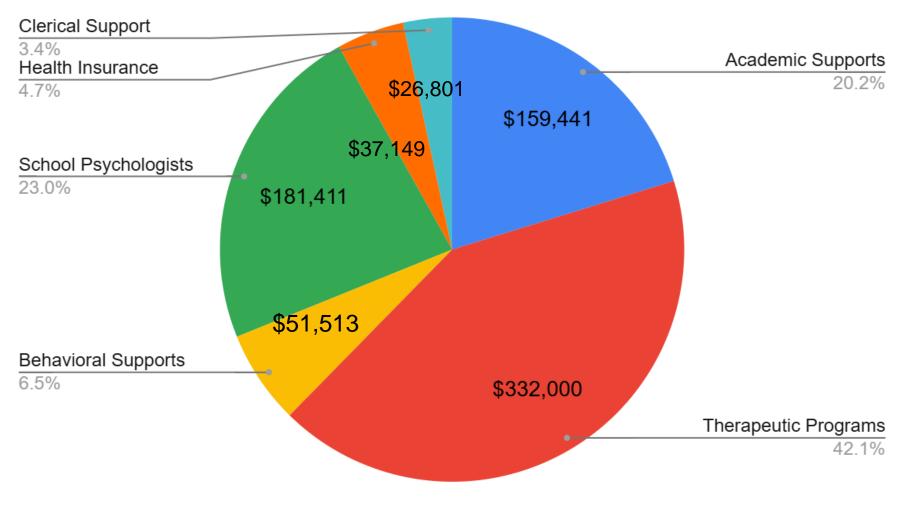

- 1:1 devices for rising 3rd and 9th grade students
- Savings through:
 - Multiplatform approach to workstations
 - Change in classroom management software
 - Reduction in subscriptions

Status of Network Infrastructure

- Network wiring 10Gbps across all network
- Switches All switches linked at 10Gbps throughput districtwide; new construction will maintain this standard.
- Servers Server NICs upgraded to 10Gbps
- Firewall Replaced in Fall of 2022
- Internet service will be increased from 1Gbps to 5Gbps bandwidth
- Access points rolling upgrades of older devices continue; new construction will be outfitted with new equipment
- Fiber backbone All switch closets connected by fiber for 10+Gbps speeds throughout each building; new construction will maintain this standard.
- WAN 10Gbps between buildings over WAN links.

Budget/Facility/Safety

- Continued proactive maintenance of all district buildings and athletic fields.
- Continued parking lot maintenance at all buildings.
- HVAC Upgrades
- Roofs repairs

Adjustments Made to Preliminary Budget

 \$1,500,000 was transferred from Capital reserve to fund 30. The transfer was made to supplement referendum funds for potential unforeseen conditions.

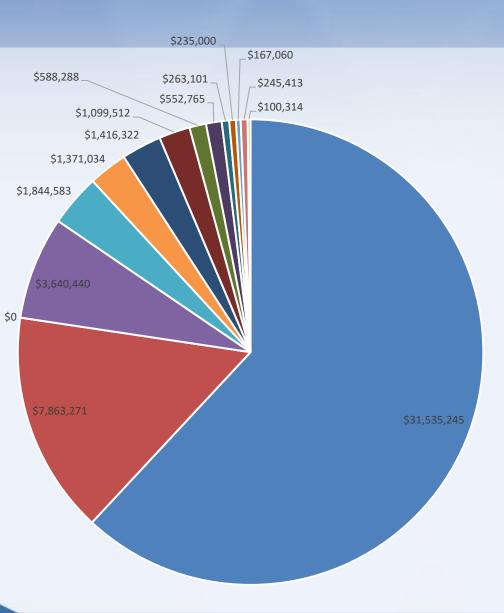

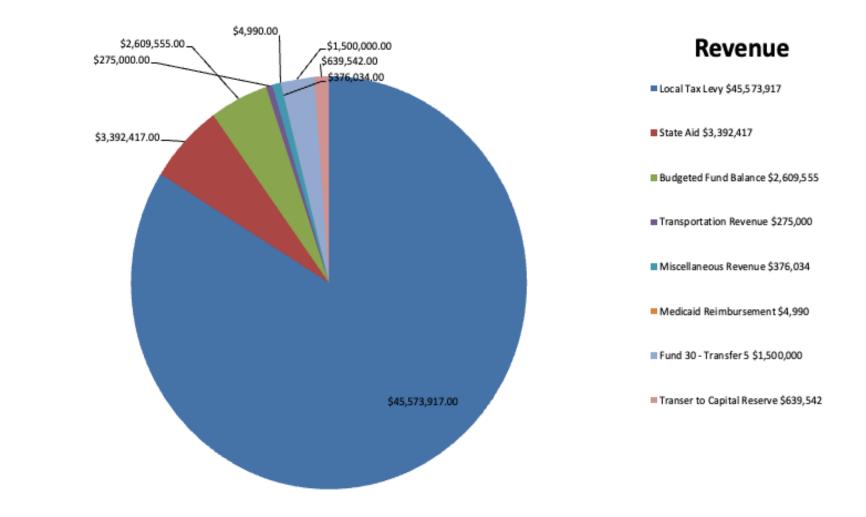
